Proposed Constitution and By-Law Amendments Offered to Region Membership For Consideration

This documents the proposed amendments to the Constitution and By-Laws of Cincinnati Region SCCA, Inc.

Proposed Amendment No. 1

Article I - Membership, Section 5. Life Membership

Require Board of Directors approval for Life Member status.

Current Wording:

A member in good standing who has been a member for twenty (20) or more continuous years shall become a life member of the Cincinnati Region SCCA. Life members will not be required to pay Regional dues. An appropriate pin shall be presented to life members proclaiming their status in the Club. Life members retail full privileges of paid Regional members.

Proposed wording:

A member in good standing who has been a member for twenty (20) or more continuous years shall become a life member of the Cincinnati Region SCCA, subject to approval of the Board of Directors. Life members will not be required to pay Regional dues. An appropriate pin shall be presented to life members proclaiming their status in the Club. Life members retail full privileges of paid Regional members.

Proposed Amendment No. 2

Article II - Meetings, Section 1. Schedule

Eliminate the requirement for twelve regular meetings. This is being proposed because in recent history we have held only eleven regular meetings January – November. A twelfth meeting is the Annual Banquet, held in January. The elimination of a numeric requirement gives the Board flexibility throughout the year.

Current Wording:

There shall be twelve regular meetings each calendar year of the members of the Club and also of the Board of Directors. These meetings shall normally be held on the third Tuesday of each month at a time and place designated by the Board of Directors.

Proposed wording:

There shall be regular meetings each calendar year of the members of the Club and also of the Board of Directors. These meetings shall normally be held on the third Tuesday of the month, at a time and place designated by the Board of Directors.

Proposed Amendment No. 3

Article II, Section 4. Notice

Allow the option of sending out meeting notices by electronic mail (email) if the member requests notices by email. This will allow the notification of meetings to be placed in the newsletter as always, but will allow members to opt out of receiving the newsletter via postal mailing, instead receiving the notice via email.

Current Wording:

A written or printed notice, stating the place, day, hour, and purpose of any meeting of the members, including special meeting, shall be given by newsletter or by the Secretary not less than seven (7) days and not more than fourteen (14) days before such meetings, to each member by mailing postpaid to the address appearing upon the records of the Club.

Proposed Wording:

A written or printed notice, stating the place, day, hour, and purpose of any meeting of the members, including special meeting, shall be given by newsletter or by the Secretary not less than seven (7) days and not more than fourteen (14) days before such meetings, to each member. Such notice shall be by mailing postpaid to the address appearing in the records of the Club, or by electronic notification through email to the address appearing in the records of the Club if the member has on file with the Club a request to send all notices by email.

Proposed Amendment No. 4

Article IV - Elected Officers, Section 2. Duties, Regional Executive

Remove the requirement that the appointed positions of Competition, Rally and Solo Chairpersons not be members of the Board of

Directors. This will allow more flexibility in chairperson appointments.

Change "Competition Chair" to "Race Chair."

Current Wording:

The Regional Executive shall preside at all the membership meetings and shall perform the duties usually pertaining to the office of "president". The Regional Executive shall appoint the following Chairpersons, subject to approval by the Board of Directors: Publication, PR/Publicity, Membership, Competition, Rally, and Solo. The appointees for Competition, Rally and Solo Chairpersons shall not be members of the Board of Directors.

Proposed Wording:

The Regional Executive shall preside at all the membership meetings and shall perform the duties usually pertaining to the office of "president." The Regional Executive shall normally appoint the following Chairpersons, and others as deemed necessary, subject to approval by the Board of Directors: Publication, PR/Publicity, Membership, Race, Time Trials, Rally, and Solo.

Proposed Amendment No. 5

Article III - Annual Dues, Section 1. Regional

Change the regional dues to \$15 as this is the current amount.

Current Wording:

Annual Regional Dues of the Club shall be \$10.00 per member, or such other amount as the Board of Directors shall deem necessary.

Proposed Wording:

Annual Regional Dues of the Club shall be \$15.00 per member, or such other amount as the Board of Directors shall deem necessary.

Proposed Amendment No. 6

Article IV - Elected Officers, Section 2. Duties, Secretary

Remove requirement for corporate seal.

Current Wording:

The Secretary shall have custody of the corporate seal and Club records.

Proposed Wording:

The Secretary shall have custody of the Club records.

Proposed Amendment No. 7

Article IV – ELECTED OFFICERS

Add SECTION 3. REMUNERATION FOR OFFICERS AND CHAIRPERSONS

Proposed Wording:

The Club shall reimburse Cincinnati SCCA Regional dues and SCCA National dues for the following elected officers and appointed chairpersons: Regional Executive, Treasurer, Race Chairperson, Time Trial Chairperson, Solo Chairperson, Rally Chairperson, Publication Chairperson (newsletter editor), and Webmaster.

The Club shall reimburse Cincinnati SCCA Regional dues and one half (1/2) SCCA National dues for the following elected officers and appointed chairpersons: Assistant Regional Executive, Secretary, PR/Publicity Chairperson, Membership Chairperson, and any other positions as deemed appropriate by the Board.

Remuneration shall be for SCCA dues paid in the year that the person holds one of the above positions, and is payable at the end of that calendar year.

In the event that one individual holds multiple positions during a calendar year, the total remuneration for that person may not exceed the sum of Cincinnati SCCA Regional dues plus SCCA National dues. Remuneration shall be for standard, individual member dues, paid by the individual, and is not to include additional fees such as for licenses.

Proposed Amendment No. 8

Article V - Board of Directors

Add a Section 7 that relates to the replacement of Board Members. Currently there is no wording the Constitution and By-Laws to address the replacement of an officer or Board member who resigns or is removed for cause.

Proposed Wording:

SECTION 7. REPLACEMENT OF BOARD MEMBER

Any Officer or Member of the Board who resigns or is removed for cause may be replaced by appointment of the Regional Executive with approval of a majority of the Board of Directors. The appointee shall serve until the next election.

Proposed Amendment No. 9

Article VII - Committees

Throughout the Article

Replace "Board" with "Committee."

Replace "Competition" with "Race."

Make all Sections consistent with respect to appointment of Chairperson, and committee composition and function.

Current Wording:

SECTION I. APPOINTMENT

The Board of Directors shall appoint such committees as it finds desirable from time to time, and shall outline the duties and responsibilities of such committee. All reports or actions taken by a committee must be approved by a majority of the entire committee. All actions taken by any committee are subject to review. (Suggested committees: Program, Race, social, Points, car Show, Hospitality, Store, and Archive.

SECTION 2. NOMINATING COMMITTEE

The Regional Executive shall appoint a Nominating Committee of four (4) members of the Club at least ninety (90) days prior to the Annual Meeting. The Committee shall prepare a slate of nominees for the annual election in accordance with Provisions of Article VI, Section I and 2.

SECTION 3. COMPETITION BOARD

The Board of Directors shall appoint a Competition Board consisting of not less than three (3) nor more than ten (10) members to serve for a term of one calendar year.

The Regional Executive shall designate one member of the Competition Board to act as Chairperson.

The membership of the Competition Board shall be drawn from among the members of the Club who are experi-

enced in the various phases of race organization such as Stewards, Starters, Timing and Scoring, Flagging and Communications, Technical Inspection, Registration, Race Chairmen, Competition Drivers, etc.

The duties of the Contest Board shall include the following:

- 1. Competition driver licensing and training.
- 2. Assist in the conduct of races sponsored by the Club.
- 3. Worker licensing and training.

SECTION 4. RALLY BOARD

The Rally Chairperson shall appoint a Rally Board consisting of not less than two (2) nor more than five (5) members. The Rally Board shall be responsible for the organization and conduct of all rallies sponsored by the Club. The Chairperson of the Rally Board shall be designated by the Regional Executive and shall be known as the "Rally Master".

SECTION 5. SOLO BOARD

The Solo Chairperson shall appoint a Solo Board consisting of not less than two (2) nor more than five (5) members. The Solo Board shall be responsible for the organization and conduct of all Solo I and Solo II events sponsored by the Club. The Chairperson of the Solo Board shall be designated by the Regional Executive and shall be known as the Solo Chairperson.

Proposed Wording:

SECTION 1. APPOINTMENT

The Board of Directors shall appoint such committees as it finds desirable from time to time, and shall outline the duties and responsibilities of such committee. All reports or actions taken by a committee must be approved by a majority of the entire committee. All actions taken by any committee are subject to review by the Board of Directors.

SECTION 2. NOMINATING COMMITTEE

The Regional Executive shall appoint a Nominating Committee consisting of not less than two (2) or more than four (4) members at least ninety (90) days prior to the Annual Meeting. The Committee shall prepare a slate of nominees for the annual election in accordance with Provisions of Article VI, Section 1 and 2.

SECTION 3. RACE AND TIME TRIAL COMMITTEE(S)

The Race Chairperson shall appoint a Race Committee consisting of not less than three (3) or more than ten (10) members to serve for a term of one calendar year. The Race Committee shall be responsible for the organization and conduct of all races sponsored by Club, in accordance with SCCA National rules.

SECTION 4. RALLY COMMITTEE

The Rally Chairperson shall appoint a Rally Committee consisting of not less than two (2) or more than five (5) members. The Rally Committee shall be responsible for the organization and conduct of all rallies sponsored by the Club, in accordance with SCCA National rules.

SECTION 5. SOLO COMMITTEE

The Solo Chairperson shall appoint a Solo Committee consisting of not less than two (2) or more than five (5) members. The Solo Committee shall be responsible for the organization and conduct of all Solo events sponsored by the Club, in accordance with SCCA National rules.

Proposed Amendment No. 10


In Article XI – Amendment, Section 1. Effective Date, change the effective date to reflect the date that any, and all, of the proposed amendments are approved per Article XI, Section 2.

Current Wording:

These By-Laws and Constitution are effective as of November 1, 1985 and shall remain in effect until properly amended.

Proposed Wording:

These By-Laws and Constitution are effective as of [date to be as approved by a vote of the General Membership] and shall remain in effect until properly amended.
